

In case we haven't met, I am Lee Sullivan, the Services Director for Oswego Industries (OI) and Arc of Oswego (Arc) since March 2022. Despite the challenging landscape of staff shortages and turnover, we've demonstrated remarkable resilience, making significant progress in Habilitation Services, bringing people back to programming, adding new youth services, and expanding classroom-style services with Smartboard Technology. Our DSPs have been the bedrock of our accomplishments, and I deeply appreciate their unwavering dedication.

New York Disability Advocates conducted a workforce study of Direct Support professionals. They learned that of the 4,497 DSPs surveyed, nearly half experienced food insecurity and unstable housing conditions due to low pay. Nearly 48% of providers were forced to close or reduce programs. Statewide vacancy rates increased 75% since prepandemic levels, 93% saw a decrease in job applicants, and 39% did not reopen due to staffing shortages.

Fortunately, OI/Arc has absorbed referrals from closed agencies and is now the leading force in Employment Services in Oswego County. Soon, it will offer services like Community-Based Pre-Voc, Employment Training Program- a discovery process for potential internships, and Pathways to Employment. The department is excited to introduce VR Technology for career exploration, allowing individuals to explore jobs safely.

We are at a historical point with a pivot in our industry with the Home and Community-Based Final Rule. This rule takes the philosophy of Intellectual Developmental Disability being in completely inclusive environments as the standard. It's a significant shift that we are prepared for and excited about. We are ready to innovate and reimagine what services look like now, and this is just the beginning of our journey.

We are committed to expanding services in Oswego County with the support of our CEO, Allen Connely, and our boards. They have increased the minimum wage rate for our DSPs. This will pave the way for a more stable future, not only for the people we serve but also for our DSPs.

INTEGRATED BUSINESS



An inside look at the Business Operations Division of Oswego Industries

From the desk of Lisa Guernsey, Director of Operations

Oswego Industries' Business Operations is a division that branches off into two distinctive directions: Operations and Services. Both Operations and Services provide employment opportunities that generate revenue, which is reinvested in products, pays employees' wages, and most importantly, enables us to meet our mission.

Business Services provides janitorial and grounds services, while Operations provides products and production services through textiles, assembly, repacking, indexing/imaging, and warehousing.

OI has three types of contracts/customers: Commercial, Source America through the AbilityOne program, and NYSID (New York Industries for the Disabled).

Business Snapshot-Series 1: Who are Source America and NYSID?

Source America - Source America is a nonprofit agency with the mission: "Increase the employment of people with disabilities by building strong partnerships with the federal government and engaging a national network of nonprofit agencies and experts." Their vision is: "Every American with a disability has career path and employment choices."

New York State Industries for the Disabled, Inc. (NYSID) - NYSID, established in 1975 and based in Albany, is a non-profit membership organization with a mission of "advancing employment and other opportunities for individuals with disabilities and qualified veterans." NYSID contracts with government entities and private companies for products and services on New York's Preferred Source List.

Our member agencies provide the individuals who make the products and/or perform the services for which NYSID contracts.

Both Source America and NYSID administer contracts, providing support throughout the bidding process and negotiations to secure opportunities. They ensure compliance once awarded and offer additional supports including engineering support, grants, and a wealth of training.

Oswego Industries currently holds one product contract with Source America and four service contracts, and two service contracts with NYSID. In our next newsletter, we will share more details on what we do, our outstanding capabilities, and our desire to partner with other local companies to grow our business and help bring more jobs to our community.

Program Happenings

From the desk of Nicole Ames, Services Manager

The Services Team has been making a significant impact in the community. Our collective efforts in the Arc of NYS 75 "Acts of Service" have been commendable, with our team members volunteering their time and skills to renovate local organizations and complete community service projects. The successful return of the first dances since COVID, the upcoming bowling league, and the first annual weekend camping trip in five years reflects our team's dedication and spirit.

Our Services Team has undergone some positive changes in its staffing structure, significantly enhancing our programming. Community Habilitation Coordinator Janel Ridgeway, in addition to her current role, now oversees the Respite program. This change has brought a more cohesive and person-centered approach to programming. Site-Based Day Habilitation Coordinator Chris Cowen started in early 2024 and has significantly improved morale in his respective departments. Adding Billing/Intake Coordinator Tabetha Hofman has improved our documentation and intake processes, ensuring a smoother and more efficient experience for those interested in enrolling.

We have also seen some other significant changes in recent years. The Plan Coordinator is the main point of contact for people supported across all services offered. For instance, a person who receives Respite, Community Habilitation, and LIFE has one Plan Coordinator overseeing their person-centered plans. The department has seen a considerable increase in teamwork and overall service. The new classroom-style service offerings are well received by the individuals being supported, as they appreciate the variety of classes available to them. Continuous onboarding and training have increased staffing to a much better level compared to last year.

Employment Services

From the desk of Su-Ann Howard, Employment Services Manager

The employment team at Oswego Industries has been active since the early 1990s. Over the years, our services have experienced significant growth and innovation. Initially, we focused mainly on finding employment for individuals within the community. However, we have since introduced new and innovative ideas to create advanced educational and employment opportunities for students and adults. Our services have expanded from traditional ianitorial and retail positions to include roles in advanced fields within the community. For example, we have assisted individuals in securing positions as teachers, air traffic controllers at airports, and members of the Coast Guard.

Over the past three years, student involvement in our schools has increased. This increased involvement has allowed students to start planning for their futures at a younger age. Our employment team is actively exploring career opportunities and college activities and organizing field trips to help students explore their interests.

Additionally, we have recently acquired VR sets to provide students and adults with a safe and exciting way to explore various interests and careers

These systems will become an integral part of our services within the school districts starting in the fall of 2024.

Our team, a dynamic and diverse group, has experienced significant growth in the past year, both in size and services. We are proud of our supportive and encouraging work environment, where many team members thrive on healthy competition. To foster this, we have implemented internal competitions aimed at securing employment bonuses for placed individuals. Our goal is to excel in placements and provide quality services each month, a testament to our dedication and drive.

We are excited to announce our plans to offer community-based services for individuals who are not yet ready for employment. This initiative will provide them with the necessary training and experience to prepare for future employment. We are also actively participating in pathways to employment, the Employment Training Program (ETP), and community-based prevocational services. We are eager to expand each of these teams to serve our community better and promote employment, underscoring our ongoing commitment to growth and innovation.

ARC OF OSWEGO COUNTY RECEIVES NYSARC TRUST GRANT

FULTON -Arc of Oswego County, a not-for-profit organization supporting people with disabilities, has been awarded \$9,236 in grants from the Trustee Management Board of NYSARC Trust Services to support Arc of Oswego County's recreation programs.

NYSARC Trust Services administers supplemental needs trusts and pooled trusts that can dramatically improve the lives of people with disabilities by enabling individuals to maintain financial eligibility for Medicaid and other means-tested government benefit programs. For 2024, NYSARC Trust Services is proud to fulfill its commitment to enhancing the lives of people with disabilities by awarding \$2,697,508 to The Arc New York Chapters statewide.

Arc of Oswego County plans to use the recreation grant funds to enable people supported to experience events that our community offers, promote physically and mentally healthy lifestyles, and allow people supported more opportunities for community integration.


